Pat and her daughter Carrie Ashbrook would also like to organize the Halloween Party for the Marquette Youth.

b) Summer Youth Program – Marquette youth

Pat would like to know why there weren't any kids participating in Marquette this year. Larry Denomie responded that Jodene Rasanen, Summer Youth Coordinator, attempted to find entities in Marquette willing to take youth workers. She could not find anyone to supervise the kids. Pat is willing to take the kids under her supervision.

c) Christmas Checks – Request for a raise in the amount

Jennifer Misegan stated that under the Tobacco Ordinance the profits from the tobacco sales are going towards the Christmas checks and the Council is anticipating an increase.

2. Debra Parrish, OCC President – Accreditation Update

The review committee of the Higher Learning Commission concurred with the visiting Evaluation Team and is recommending OCC for initial candidacy status. There is one more step in this process, next it will go before the Board of Trustees for the Higher Learning Commission and they will be meeting this month. When they send an official letter, OCC will have their official notification and be able to move forward with plans for additional funding. They will apply for the BIA funding, and submit the resolution from the Tribal Council to conduct a feasibility study for the college. They will also be making applications for funds through HUD, they will also seek assistance from the American Indian Higher Education Consortium for the Department of Education and Department of Defense funding. They also need to revise the Tribal Council resolution for the Broadband Technology Opportunity Application Program for a 1.9 million expansion to the college. These are federal funds that will be approved next month and submitted to Senator Levin's office and he will move forward on their behalf. Debbie has also notified the local universities that the transfer credit agreements will be updated with Northern, Finlandia and Michigan Tech. They are also working on their video conferencing system to hold interactive classes. An MOA draft to the Tribal Council, CEO's office, Tribal Chairman's office and Accounting Department was submitted for review.

The college is working on mapping with the THPO office for the Pinery Cemetery. They will be able to rebuild the spirit houses and crosses at the Cemetery.

The college will be in candidacy status four years before full accreditation.

Debbie has submitted a request for membership with AHIC. She plans to add additional programs such as a business program and Native American Studies program.
