## K. Old Business:

1. 2<sup>nd</sup> Reading Resolution KB-015-2014 Prohibit Alcoholic Beverages on Powwow Grounds

Ogimaa Shalifoe opened up the floor for comments. Jennifer would like this to be posted at the campgrounds so that everyone has to comply not just those having jurisdiction over it. RD Curtis stated the only reason they are asking for this is because of burial grounds down there and they do not want them to be disturbed. Ogimaa Shalifoe read the letter that was attached to this Resolution by Gary Loonsfoot, Jr. why THPO is requesting this Resolution. Don Messer asked about the burial mounds that were down near the marina also and they will be protected this year. Someone asked if alcohol is permitted down near the marina and Sand Point down there and they were said yes and he says that it makes sense to ban alcohol near the arena and areas where there are burial mounds. If they want to have alcoholic beverages they can go over to the other campsite areas. Eddy also stated that we are taking a comprehensive approach for our ancestral burial mounds so that people are more aware of protecting them since they are not buried in our two local cemeteries because most of the mounds are not protected and in an open area and we are trying to fence them off and marked them better. Debbie Picciano asked if that includes the pavilion also and that if someone wants to have a party they can't. Yes it does include the pavilion because it is within the pow-wow grounds. Chris agrees with Eddy and understands where THPO is coming from but you also have a lot of people who ask to use the pavilions for parties and from people who are coming home on vacations and such. Then we telling people what they can or can't do down there because the main purpose of that site is the campground then we need to think of the protection of the

burial grounds and our ancestors down there that would be prudent and also its going to be hard. Ogimaa stated that we can make out a happy/medium solution for people. Chris states that disallowing alcoholic beverages to respect the ancestors down there but we also have to look at it because it is a park. How many mounds are down there? Eddy says they do not want to get into the details on that. As far as he is concerned that it is not illegal to drink in the cemeteries as far as he knows. Chris states that he believes that people respect the non-alcoholic beverages during the week of the Pow-wow but at the same time when people are camping they like to have a few drinks while relaxing by the fire and such. Most Council agrees that this is a tough situation. Debbie Picciano stated that it is a campground and that you are going to lose revenue because of this resolution.
