- K. Recognize Scheduled Delegation/Individuals:
 - 1. Anne Koski, Baraga County Treasurer Anne apologized to the Council and the audience and explained she was misquoted in the papers in the article "Baraga County Mulls Deficit." She stated that a non-native sold 51% of his business to a Tribal Member so the property was taken off the tax rolls. In the paper she referred to county residents or business owners "using every service in the county, but aren't paying for it when they sell or deed their property to tribal members and the property is removed from the tax rolls. It appears that non-tribal people are taking advantage of a property tax exemption." This was left out of her quote.
 - 2. Paul Smith "Life" Subscription Proposal (Living Intentionally For Excellence) which is his small Tribal business with the company LIFE.

Paul is requesting the Council purchase self-help materials that can be distributed to Departments within the Tribe. Susan LaFernier suggested the Library review/purchase the information/material.

He would like to volunteer his time with the Tribe's Youth to teach leadership qualities; in return for equal pay of what he presently earns working for the Marquette Casino.

The Council would like more time to review his information. (Paul provided brochures, compact discs, audios, etc.)

Susan suggested May 5th and the Articles of Incorporation could come that same day.

Jean Jokinen stated the Community wanted a public hearing with all attorneys present so the people would understand what the Articles and amendments are and did not get that.

Eddy Edwards stated that the Tribal Attorney has had the amendments for over a year. These Articles are from the model given by Lance Morgan and deserve a vote up or down.

Susan disagreed. She stated these Articles have been presented six different times, by three different people, under three different names; and each of them is different.

I do not know the reason for his termination today and the Council did not discuss his performance formally or devise a plan of continuance. This puts us in great distress. I would like to personally thank Mr. Baker for all of his work with this Tribe and on our behalf. We are doing exactly what we continually state we are against.

President Swartz concurred and thanked Mr. Baker for all of the work he has done for the Tribe.
