 Cultural Committee – Anishinaabemowin – Language Immersion Proposal for accredited on site classes at KBIC and a Memorandum of Understanding between the KBIC and Bay Mills Community College.

Present: Ted Holappa, Director of Anishinaabemowin Pane Program and representing Michael Parish, President of BMCC, Barb Nolan, Associate Director of Anishinaabemowin Pane

Program and Certified Fluent Immersion Instructor, Rhonda Hopkins, Certified Fluent Immersion Instructor, Peggy Dunn, Beverly Lussier, Peggy Hemenway, Gerry Mantila, Cultural Committee Chair, Summer Cohen, THPO, Marty Curtis.

Gerry Mantila, Chairman of the Cultural Committee, discussed with the Council that the Committee members have spent a lot of time attending Language Conferences over the past year and fulfilling the requirements of the ANA Language Grant. The application deadline was missed for the upcoming year and the program currently running will be ending in September, which means there will be two years missed of language instruction so the Committee has been working with Ted Holappa to try and get the Immersion Language Program here at KBIC that can be started this year in the Fall. It is the consensus of the Cultural Committee and Elder's Panel to go with Immersion type learning over the grammar type of language teaching.

Ted presented the Language Program to the Council and explained the program will be fully accredited and transferable through the Bay Mills Community College. He explained the research of his program and studies that have been done on how language is acquired and how the grammar type language teaching over the past 35 years has never produced a fluent speaker. The Immersion Program is based on sound linguistic principles of how people acquire a language. He said you first have to hear the language, then listen to the language and make connections to the actions and the sounds and finally understanding, comprehending what is being said. The program is designed for the students to reach 2000 hours of immersion listening at which point the student is fully comprehensive and understanding the speech, at 6000 hours the student is a functional bi-lingual in Anishinaabemowin and in English and if the student has the opportunity to reach 12,000 hours the student is fully fluent.

Barb Nolan and Rhonda Hopkins performed a skit for the Council in the language to show them an example of how the classes are done, in complete immersion.

Ted explained that the Community has to start with adult functional bilinguals, speakers, who will then start the immersion daycares for the children, which will eventually create a fluent community. To start the classes a room will be required to accommodate the number of students and a "closet" room with props for the instructor's use. The cost for KBIC for one year will be approximately \$30,000.00 that could be offset by student's financial aid awards.
