1. Joe Tormala/Military Order of the Purple Heart – He presented a plaque of appreciation for their 72<sup>nd</sup> State Fall Convention held at the Ojibwa Casino Resort to the Council
2. Carl Lindquist/Superior Watershed Partnership – Carl said they are trying to get the Salmon Trout River on America's ten most endangered rivers list. Carl also mentioned a youth conservation program they offer in the summer. He requested the Council's continued support on the Environmental Education for Youth for 2008 as a letter was sent on October 16, 2007 to participate in this program.

3. Glenn Bressette Jr./"Equal Rights Concern for Marquette" Group – Glenn addressed the Council under advisement from his elders. He had questions on medical coverage on and off the reservation, voting rights, and if a Marquette representative can run for Council under the L'Anse district. He also had questions regarding the children's parties in Marquette. There are funds allocated in the budget for the Children's Christmas Party. It was stated that Glen's concerns will be addressed.
