She stated the Tribe should actively pursue at the Federal level, she does not believe we had to exhaust all State avenues. She handed out an excerpt from the Petitioners brief for review on the mining permit regarding the NPDES Permit.

Mr. Durocher stated Dorsey & Whitney's involvement was only to prepare two memos regarding treaty claims on tribal resources in February 2007 and to give an opinion on the probability of Federal Court abstentions before going to State Court.
