



## **KBIC Senior & Physically Disabled** *Snow Removal Services*

The KBIC Public Works Department requests your patience and understanding during the winter season. We have developed these requirements and guidelines to better service each qualified applicant in a timely manner.

### **Eligibility Requirements:**

- ❖ Services are open to all KBIC Seniors 62 years of age and older living on/or within a 5-mile radius of the reservation.
- ❖ Services are open to physically disabled KBIC members living on the reservation.
  - To qualify you must be an individual living by yourself and have a physical impairment that limits movement.
  - Must not have able-bodied household members living with you.
  - Must provide statement from Medical Professional stating you are physically unable to shovel on your own.
- ❖ You must provide proof of residency and tribal enrollment (i.e. Tribal ID, Driver's License)
  - You must be the homeowner of the residence, if you are renting, the lease must be in seniors/disabled persons name.
  - Services are only open to Baraga County residents.

### **Participant Guidelines:**

- ❖ Snowplowing will be done when four (4") or more inches of snow has fallen. Clearly mark the areas where there are water wells and drain fields.
- ❖ Remove any large rocks and debris that may be in the way of a plow.
- ❖ Snowplowing services are strictly for driveways.
- ❖ It is the homeowner's responsibility to shovel entryways and/or sidewalks of home.
- ❖ If possible, vehicle(s) should be moved to allow proper snowplow removal of your driveway. If vehicles are not moved during plow service, they are only able to access what is available.
- ❖ Any animals should be kept in a safe place and distance away from the driveway.
